## 2. NAME OF THE VETERINARY MEDICINAL PRODUCT THIABENDAZOLE/ PROVET

Tablets 2000mg/tab Thiabendazole Cattle, Sheep, Goats

#### 3. STATEMENT OF THE ACTIVE SUBSTANCE AND OTHER INGREDIENTS

Each tablet contains:

**Active substance:** 2 g Thiabendazole (2-(4-Thiazolyl)-benzimidazole)

**Excipients:** Cellulose microcrystalline, Hydrogenated castor oil, Sodium starch glycollate, Sodium lauryl sulfate, Magnesium stearate, Povidone (Polyvinylpyrrolidone), Lactose, Polysorbate 80, Starch maize, Alcohol

#### 4. INDICATIONS

It is recommended for the treatment of parasitic infestations of animals caused by mature and immature stages of gastrointestinal and pulmonary roundworms. In severe cases of pulmonary strongyliasis, use double the dose indicated for gastrointestinal strongyliasis. It is also recommended for the treatment against *hepatic dicrocoeliosis*.

#### 5. CONTRAINDICATIONS

None.

#### 6. ADVERSE REACTIONS

Prolonged and improper dosage may lead to the development of resistant parasitic strains especially in *Haemonchus contortus, Ostertagia circumcincta* and *Trichostrongylus colubriformis*. This is avoided by using the appropriate therapeutic dose, at regular intervals, and the alteration of the chemical group of anthelmintics.

The frequency of adverse reactions is defined using the following convention:

- very common (more than 1 in 10 animals treated displaying adverse reaction(s))
- common (more than 1 but less than 10 animals in 100 animals treated)
- uncommon (more than 1 but less than 10 animals in 1,000 animals treated)
- rare (more than 1 but less than 10 animals in 10,000 animals treated)
- very rare (less than 1 animal in 10,000 animals treated, including isolated reports).

If you notice any side effects, even those not already listed in this package leaflet or you think that the medicine has not worked, please inform your veterinary surgeon.

#### 12. SPECIAL WARNINGS

Thiabendazole is incompatible with products containing copper and cobalt salts. It is synergistic with other anthelmintics and especially with bithionol sulfoxide.
